OBJECTIONS OF CHARLES BRADY, ET AL, TO ADMINISTRATOR'S PETITION  
FOR DISTRIBUTION.

Come now your petitioners, Charles Brady, John Dunne, Anne Dunne and Mathew Dunne, residents of Leitrim, County Cavan, of Ireland; Patrick Dolan, a resident of Ballinacorney County Meath, Ireland; Mary Coffey, resident of Navan, County Meath, Ireland; Lizzie Daly, a resident of Carnaross, County Meath, Ireland; Lizzie Dunne and Bridget Dunne, residents of New York, N. Y., and file their objections to the Petition for Distribution in the above entitled Estate heretofore filed in this Court, by the Administrator of said estate, and as grounds for such objections allege and deny:

I.

That said William Brady, died intestate on or about the 28th day of October, A. D., 1909, in the County of Los Angeles, State of California; that said deceased, at the time of his death, was a resident of said County and State, and left an estate in said County and State, consisting of personal property valued at \$71,490.34; that at the time of his death, said deceased was a widower; that in the year of 1883, said deceased had intermarried with one, Harriet Hayes, who remained his wife until the year 1894, at which time she died; that both said deceased and his said wife, died leaving no issue then surviving.

II.

That your petitioner, Charles Brady, is the Uncle of the half-blood of said William Brady, deceased, and your petitioners, Patrick Dolan, Mary Coffey, Lizzie Daly, Lizzie Dunne, John Dunne, Anne Dunne, Bridget Dunne and Mathew Dunne, are cousins of the half-blood of said William Brady, deceased, and your said petitioners are the sole surviving heirs at law of said William Brady, deceased.

III.

That at the time of the death of said William Brady, deceased, his estate consisted exclusively of his own property, none of which had been community property during the life time of said deceased and Harriet Hayes Brady, his said pre-deceased spouse.

WHEREFORE, your said petitioners pray that the petition of the Administrator of said Estate for Distribution thereof to the State of California, be not granted, and that said Estate be distributed to your said petitioners as the heirs at law of said William Brady, deceased.
