OBJECTIONS OF CHARLES BRADY, ET AL, TO PETITION FOR DISTRIBUTION
OF HARRIET S. STONE, ET AL.

Come now your petitioners, Charles Brady, John Dunne, Anne Dunne and Mathew Dunne, residents of Leitrim, County Cavan, of Ireland; Patrick Dolan, a resident of Ballorteara, County Meath, Ireland; Mary Coffey, resident of Navan, County Meath, Ireland; Lizzie Daly, a resident of Carnaross, County Meath, Ireland; Lizzie Dunne and Bridget Dunne, residents of New York, N. Y., and file their objections to the Petition for Distribution in the above entitled Estate heretofore filed in this Court, by Harriet S. Stone, J. Lotta Shedd, Susan M. Sanford, Lilly M. Reynolds Morgan, Charles G. Reynolds, Thomas R. Reynolds, Stephen M. Hayes, George Hayes, Mina Pydge, Mamie Grove, Charles B. Hayes, and as grounds for such objections allege and deny:

I.

Deny that all of the property of said Estate, or any portion thereof, was or is the community property of said William Brady, deceased, and Harriet Hayes Brady, deceased, and deny that the property of said Estate or any part thereof was or is the proceeds and profits of community property of said William Brady, and said Harriet Hayes Brady; on the contrary, your petitioners are informed and believe and upon such information and belief, allege that said property of said Estate and all of said property was at the time of the death of said William Brady, and ever since has been and now is, exclusively the individual property of said William Brady, deceased, and none of said property was community property of said William Brady and Harriet Hayes Brady during their life time.

II.

Your petitioners deny the allegation in paragraph III of said petition, that said William Brady left no heirs at law, but as to the remainder of the allegations contained in said paragraph, they have no information sufficient to form a belief, and therefore they deny said allegations, and deny that there are heirs at law of said Harriet Hayes Brady or any heir at law of said Harriet Hayes Brady, who are, or who is entitled to share in any community property of said William Brady and Harriet Hayes Brady, or of any property of said Estate, and deny that there are any heirs or heirs at law of said Harriet Hayes Brady whatsoever.
